# **1. CALL TO ORDER**

The meeting was called to order at 5:34 p.m. President Ralston asked George Lange with Conejo Recreation and Park to lead the group in reciting the Pledge of Allegiance.

# 2. APPROVAL OF MINUTES: BOARD MEETING OCTOBER 3, 2023

Motion to approve the Minutes from the October 3, 2023 membership meeting, Elaine Freeman; Second, Bruce Dandy; Voice vote: All in favor, none opposed. Motion carries unanimously.

# 3. TREASURER'S REPORT

Mr. Pendleton reported on the October 2023 and November 2023 balance sheets. He informed members that VCSDA is transitioning banks from Wells Fargo to City National Bank. This change is due to the association not being able to meet Wells Fargo's requirements of a business physical address.

### 4. GUEST SPEAKER

Treasurer Pendleton introduced dinner sponsor and speaker, Jordan Chriss, with Sitelogiq. Jordan provided a brief overview of Sitelogiq's presence in California as a licensed general contractor delivering world-class energy, renewable, mobility, and infrastructure programs for State and Local Governments. He explained that special districts benefit from implementing energy projects involving installation or modification for improvements of an energy-efficient or renewable energy system, resulting in savings of funds that can be repurposed to pay for critical infrastructure upgrades. He informed members of funding opportunities available from federal, state, and/or local levels. He also discussed the Inflation Reduction Act (IRA) that allows Local Governments to obtain a federal tax credit in the form of a rebate for solar, energy storage, microgrid controllers, among additional credits.

### 5. MEMBER ANNOUNCEMENTS

Bruce Dandy of United Water Conservation District announced he will be resigning from the board early 2024.

## 6. REPORTS

**CSDA Report -** CSDA President Elaine Magner announced the new field coordinator for the Coastal Network, Richelle Noroyan, will attend the April 2024 meeting. She encouraged districts to complete the District of Distinction Accreditation through SDLF. To help with this, there are two upcoming SDLA Conference in San Diego and San Luis Obispo, and virtual workshops available. Director Magner mentioned the CSDA Annual Conference & Exhibitor Showcase in Indian Wells, September 9-12, 2024.

**Legislative Update** - Director Freeman provided an overview of the legislative report and highlighted select bills, including SB 616.
