### County of Ventura

- Fictitious Business Name Statement
  - o The Treasurer filed on August 9, July 2023 and published in the newspaper
  - The FBN Statement must be refiled every 5 years
    - The current FBN Statement expires on August 9, 2028
  - Current "doing business as" (DBA):
    - Ventura County Special District Association
    - Ventura County Special Districts Association

### State of California

- Secretary of State (SOS)
  - The Treasurer has established an online account, filed the Statement of Information (SOI) as required by SOS, and kept current the list of VCSDA corporate officers on the website.
    - When information changes e.g. physical address, mailing address, list of corporate officers, the current Treasurer will need to make sure the SOS website is updated.
  - Regardless, the SOI must be updated periodically even if there is no change. The SOS requires VCSDA to update the SOI again by March 31, 2026.
  - As of January 21, 2025, the SOS shows VCSDA's status as "Active" and:
    - Good Standing SOS
    - Good Standing FTB
    - Good Standing Agent (Brian Pendleton)
    - Good Standing VCFCF

# VCSDA Treasurer's Report Brian Pendleton, CSDM General Manager, Ventura Port District January 21, 2025

- California Franchise Tax Board (FTB)
  - The Treasurer has established an online account and directed Hayman Consulting to file prior and current years when applicable:
    - Prior Years Filed 2018-2020
    - Current Years Filed 2021-2023
  - The State has processed 2018, 2019, 2020 and 2021 tax returns and shows VCSDA owing \$0 as of January 3, 2025.
- Internal Revenue Service (IRS)
  - The Treasurer has established an online account and directed Hayman Consulting to file prior and current years:
    - Prior Years 2018-2020
    - Current Years 2021-2023
    - All tax returns have been filed by Hayman Consulting
  - The Treasurer has spoken directly with the IRS (January 2025) regarding the tax returns and VCSDA's current non-profit status. The IRS requires additional form/documentation to be electronically filed in support of VCSDA's application for federal reinstatement as a non-profit. The status was revoked when the IRS determined (based on its records) that 2018-2020 tax returns were not filed. The Treasurer has provided IRS information to Hayman Consulting from the communication and directed the IRS form be filed to facilitate the resolution of the reinstatement process.

### VCSDA Filing System

- The Treasurer has developed a new standardized filing system for 9 calendar years dating back to 2017 (the year before VCSDA incorporated) through 2025 including the following for each calendar:
  - Correspondence
  - Financial Statements
  - o Receipts, Invoices and Check Stubs
  - Tax Documents
